The MOAA Nassau Florida Chapter will be having its monthly meeting on 11 March 2025 @ 1130.

Our guest speaker will be Kenneth R. Timmerman, a best-selling author and the executive director of the Foundation for Democracy in Iran, an organization that works to support democratic



movements in Iran. He obtained a BA from Goddard College in 1973 and an M.A. from Brown University in 1976. He moved to France, where he pursued a career as a novelist, publishing a novel called *Wren Hunt* in 1976 and a novella called *The Iskra Scrolls* in 1980. In the early 1980s, Timmerman became a Middle East correspondent for The Atlanta Journal-Constitution and developed an expertise in arms trade. In 1982, he was taken prisoner for 24 days by Fatah guerrillas in Lebanon. He was the first U.S. journalist on the scene when Islamic militants bombed the U.S. Embassy in 1983. Ken has published numerous books and was

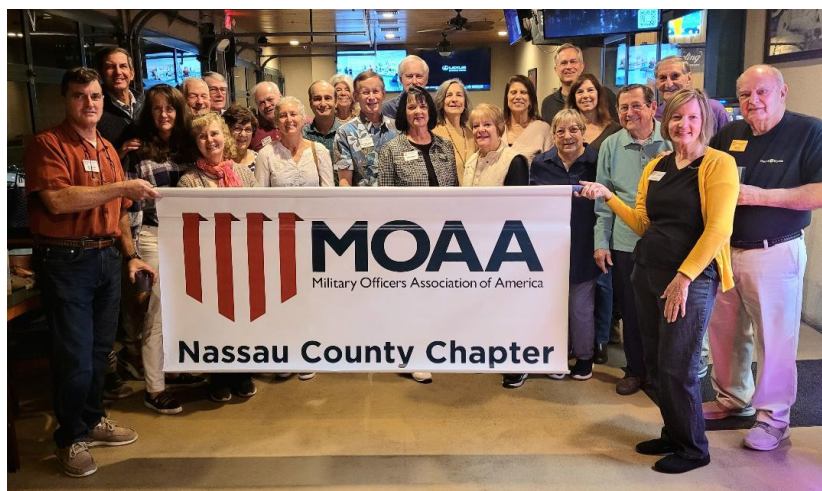

MOAA 2025 ISSUES

Currently serving unaccompanied housing:

Recent reporting from the Government Accountability Office (GAO) reveals the myriad challenges servicemembers in unaccompanied housing are facing.

Retirees/Veterans Toxic exposure:

MOAA will focus on capitalizing on our recently released report *Ending the Wait for Toxic-Exposed veterans* to advocate for veterans exposed to toxic materials during their service.

Family/Survivors Spouse employment:

Rates of unemployment for military spouses continue to be four to five times higher than the national average.

DOD/Health Care access to care:

DOD has acknowledged that congressionally directed reforms to the Military Health System (MHS), together with U.S. medical workforce volatility, exacerbated long-standing access challenges and led to a destabilized MHS that does not consistently deliver timely care to beneficiaries.
